A7 - Dr. Thomas Prestwood Lucas (1801-71)

Dr. Prestwood Lucas was born in Carmarthen in 1801, and graduated MD from Edinburgh in 1825, gaining a Partisian qualification in 1826. Mr. Henry Lucas, his father, was the first physician to the Brecknock Infirmary (1832) and died in office as Mayor of Brecon, 1840. On his death, Prestwood Lucas, who had recently been appointed to the Swansea Infirmary, after 12 years service abroad with the Royal Artillery, took on Henry Lucas's Brecon practice. In 1859 he became a member of the Royal College of Physicians. He became a Town Councillor in 1866, and an Alderman the following year, and was also a Governor of Christ's College and Deputy Lieutenant of the County. He married Sarah (Ker) in 1853, and died in 1871.

A8 - Papers of the Breconshire Insurance Committee

In 1912 an Act was passed requiring a fixed contribution to be deducted from the wages of lower-paid "heads of households" (nicknamed the "Lloyd George stamp") to insure them against medical expenses.

Insurance Committees were established in all counties and county boroughs to administer the benefits to the working population. These Committees were composed of local government representatives together with medical and lay representation. They coped with the financial business of the practitioners' treatment costs and "capitation fees", and also with complaints against doctors.

The committees operated until 1948 and the introduction of the National Health Service, proposed by the Beveridge Report and embodied in the Act of 1946. Many of the Insurance Committee's functions, and their extension to other aspects of medical care, were then taken over by the Executive Council.

The Minutes of the Breconshire Insurance (or, from 1944, "Local Medical") Committee comprise nine bound volumes, between 1912-1954, and have been presented to the Brecknock Museum by the Executive Council, on the eve of its replacement by the area medical boards in 1974.

A41/1/1 This item is an 1684 pocket almanac *The British Merlin*, produced by Cardanus Riders, published in London by Thomas Newcomb, and owned by Owen Brigstock, a justice of the peace and land owner (?Llandybie/Llandeilo area)

His jottings are concerned with:

1. Legal matters: "the heads of the agreement made by Mr Rowland Gwynne & Myself ... betwene Mr David Lloyd and his aunt"

2. Financial matters: "received by Owen Brigstock esqr, the sum of fifteen pounds towards defraying of the Duke of Bedford's entertaynment. I say received by me (Thos Wms Savory) (9 Oct. 1684), (1684 was the year of the Duke of Beaufort's Progress)

- 3. Petty disbursements: "15d for pulling down of the ould wall"
- 4. appointments: "the muster to be uppon the 16th June 1684"

5. domestic matters: "Thomas John Pritchard is to playster and seele all the kitching & closett within the kitching ... to colour all the windows ... in read first & afterward in white"

The almanac also contains a few financial jottings made by Robert Jones between 1792-1801.

A42/1/1 "Numeration"; a mathematics textbook of simple explanations and examples c1632. compiled in a fine ornamented script by one hand, possibly that of a West Country schoolmaster.

On the end papers are the names of "Charles Browne" and Hugh and John Davis (roughly contemporary hand); John Davies of "Llanavan", Brecs, and "Thos Powell of "Llanahangell Brynpabyan" (a note of loan, later date); "John Arthur" has scribbled throughout the volume c1815.

The book was found above a blacksmith's shop in Cradoc and presented to the museum by E. Brecon Powell c1935.
