#### Records of the Bevan estate, Llangammarch, Breconshire

These papers relate to the estates purchased over the course of the 18th and 19th centuries by John Bevan and his descendants of the same name. Most of the properties are in the parish of Llangammarch, in north Breconshire. The deeds were bound together in bundles relating to different properties, with one bundle entitled "promiscuous deeds", mainly containing wills and mortgage deeds.

A final concord was the result of a fictitious and collusive action at law, in which the person buying land took the vendor to court, claiming that the land was his all along, whereupon the vendor agrees to lose the case. The result was an official entry in the court registers, and the document listed above is a copy of this entry. The whole exercise was an attempt to have a conveyance officially registered or recognised at a time when there was no land registry for the confirmation of title. Unfortunately the property is only ever described in this very stylised way and never named.
