Consideration: 1 will take no further legal proceedings against 2 unless he defaults on payment.

NB. An entry in the parish register for Llansantffraid Cwmteuddwr records the baptism of Charles Stewart Worthing son of Hannah Worthing, singlewoman of Water Lane, Rhayader, on 13th May 1892 (birth date is 16th December 1885).

His entry in the baptism register is preceded by entries for Maud (born 7 August 1891) & Thomas (born 4th July 1888) both children of Hannah Worthing. All four can be found on the 1891 census living at 1 Mill Cottages in Rhayader.
