Ebenezer Davies, a tailor, lived at Pantglas a farm on the Llanidloes Road about five miles out of Machynlleth and also at Brynllwydwen, Machynlleth. He married Catherine Morris in 1852 and they had a daughter named Elizabeth. He died on 15 July 1849

Elizabeth Davies married Robert Rees (1777-1829), a member of a Machynlleth family being the son of Lewis Rees and his second wife Jane (1777-1805). Robert and Elizabeth Rees had with five other children including a daughter named Jane.

Jane Rees (1819–1884), the daughter of Robert Rees and Elizabeth (nee Davies), married the Reverend John Rees (1810-1898), the son of Edward Rees and his wife Jemima who lived at Penhelyn, Llangurig. He went on to become a well-known Welsh Methodist Minister who served in a number of chapels in South and Mid Wales, and is a party to the marriage settlement (M/DX/62/D/2).

It is through descent from John & Jane Rees' granddaughter, Frieda Rees, the daughter of their son John, that the items came into the possession of the depositor.
