Bausley and Criggion (Crugion) formed townships of the Shropshire ecclesiastical parish of Alberbury till 1864 when they were amalgamated to form the ecclesiastical parish of Criggion. Both townships were made into civil parishes in 1894 but were amalgamated in 1939
